

JOHNSTON COUNTY FRATERNAL ORDER OF POLICE LODGE #88
APPLICATION FOR FINANCIAL ASSISTANCE

You may apply for financial assistance from a benevolent fund created by the Johnston County Fraternal Order of Police Lodge #88, if you are a North Carolina law enforcement officer, or the natural or adopted child or step-child living in the household of a North Carolina law enforcement officer who is a sworn officer and a member of the Johnston County Fraternal Order of Police Lodge #88 for at least 1 (one) year in good standing and meet standards set forth below. If you are applying for the scholarship, you must be enrolled or accepted for admission in a college, vocational training school, or other educational institution approved by the Johnston County Fraternal Order of Police Lodge #88.

MISSION

1. To assist children of North Carolina law enforcement officers by providing funds so that they complete their educational studies in appropriate post-secondary educational institutions, including college and vocational training, with grants and scholarship awards made through the recipient's educational institution, complete Application Section Parts I, II, III, IV, and V.
2. To assist North Carolina law enforcement officers and/or children with educational opportunities for the furtherance of their careers, complete Application Section Parts I, III, IV, and V.
3. To encourage the exchange of information, and other community involvement, between law enforcement and North Carolina's citizens about the above and other law enforcement and safety issues, so that there may be cooperation and coordinated assistance between and among law enforcement officers who work and reside within North Carolina, local jurisdictions, and the citizens of North Carolina.

A student meeting these standards may receive a scholarship of up to \$500 per academic year (but no more than a cumulative total of \$2,000 per student). The amount actually awarded will depend upon many factors, including the amount available for awards, the number of applicants and the cost of the institutions including living arrangements, tuition, and other sources of funding. Each application for a scholarship will be reviewed by the Johnston County Fraternal Order of Police Lodge #88 on a year-by-year basis. A renewal application must be filed each year.

MANNER OF APPLICATION

1. Applicants must complete Parts I – V of this application. Completed application and most recent academic transcript should be turned in to the Johnston County Fraternal Order of Police Lodge #88.
2. How to Submit: Above documents may be given in person to any Johnston County Fraternal Order of Police Lodge #88 officer. See www.ncfop88.org for a list of the officers. 3. Deadline: The Johnston County Fraternal Order of Police Lodge #88 will accept no applications/transcripts after October 19, 2021.
